## **STEP FIVE**

The secrets we share

There's nothing like telling another alcoholic who we really are and what we have done

I've always believed that it doesn't matter how you do the Steps, just so long as you do them. My brain damage, youth and inability to comprehend this new sober language along with my persistent disease seemed to thwart my every effort to do them. I made many fumbles, false starts, off-task attempts, and these efforts failed, but I never stopped trying to get the Steps done. With the kindness and patience of people in AA, I persevered and eventually completed the Steps over a few years.

I'm sitting in a hotel in Barcelona right now reflecting on this as I look down and see the beaded bracelet a young girl who I once sponsored made for me. The bracelet's black beads still shine and the wings and cross on it still look new.

Although I can't remember my sponsee's name right now, I remember the most important lesson I learned from her. We went through the first four Steps together. When we moved onto the Fifth Step, she said she wanted to do it with a priest or a minister. It was the first time I had heard a request like that, but I didn't think twice in helping her find someone. I took her to a female minister whom I had heard about and the appointment was made and her Fifth Step was completed. She and I worked on the rest of the Steps as best we could. It didn't take long for her to start drinking again and leave AA.

I don't know the "right" way to do the Steps...

What I do know is that telling another alcoholic who you really are, what you have done, what you are ashamed of, what you are proud of, what you regret, what you need forgiveness for and what is haunting you freed me in a way that nothing or no one else could.

AA is the great equalizer. When you work the Steps in AA, you become a member of what I call a "love army," and that means you can help another alcoholic when no one else can, even someone from your "real" life who may know you well and may see you all the time. In the AA Fellowship, we can share the story of what we have done and how we did it and that's not something we will necessarily be able to share with other people in a church. That is my personal experience from working with sponsees.

One of my beautiful "pigeons," who I sponsored for years and did the Steps with, decided to tell me a secret on her deathbed. This was something she'd left out of the Fifth Step she had done with me. With the grace of God, I was able to tell her that I had done the same thing, and only my sponsor knew what I had done from my own Fifth Step. We both cried and she said she felt a peace beyond words. She died with her sobriety, her soul relieved and her blue eyes sparkling.

There is something so holy about our sharing our Fifth Steps. I still believe any way you can get started is good, but ultimately, the way members did it 80-something years ago seems to be the best way.

I get on a ship today with 70 other alcoholics in recovery to sail around the Mediterranean. For today, we have all completed our Steps in a way that allows us enough gratitude and joy to show up for our own lives and each other's and travel the world in complete freedom. How amazing is that?

**Last Month's minutes:** The committee reviewed the February 2022 minutes. **Thaddeus** made a motion to approve the minutes, **Will** seconded, and the motion was passed unanimously.

**Financial Report:**

**Tom** presented the March financial report:

**Current Month:** Checking and savings accounts are reconciled – total cash as of 3/31/22 is \$60,162.79. Net of \$145.00 of sales tax payable leaves \$60,017.79 of available cash at 3/31/22. Monthly revenues were \$6,178.61 and monthly expenses were \$7,189.76 resulting in a net loss of (\$1,011.15). Contributions were \$3,561.65 (this is trending upward) and literature sales were \$1,991.50 (this is trending flat). The monthly expenses included a third payroll of ~ \$1,500.

**Year to Date:** As of 3/31/22, with the year 25% complete the revenues are \$16,603.54 which is 20.56% of the budgeted amount (well below the budgeted amount). Total contributions are at 16.75% of the budgeted amount, group contributions are at 19.64% of the budgeted amount and individual contributions are at 15.25% of the budgeted amount. Literature sales are at 27.52% of the budgeted amount. Year-to-date expenses are \$20,002.06 which is 24.76% of the budgeted amount (right on budget). Year-to-date loss is (\$3,398.52) vs net income of \$1,349.41 as of 3/31/21.

**Comparison Year to Date March 2022 vs March 2021:** Year-to-date revenues are a little better the prior year - \$16,603.54 for year to date as of 3/31/22 versus \$15,852.02 for year to date as of 3/31/21 (up 4.74%). The year-to-date expenses are significantly greater than the prior year - \$20,002.06 for year to date as of 3/31/22 versus \$14,475.61 for year to date as of 3/31/21 (up 38.18%), due mainly to resuming literature purchases for the Roundup in 2022 (no Roundup in 2021), as well as escalating utilities costs.

**Service Center:** There were 169 total calls in March, up 19% from February, and 98 total office visits, up 11% from the previous month. Service Center staff responded to 156 email inquiries, up 68% from February.

**Intergroup: Thaddeus** summarized the March Intergroup meeting. There were three new IRs: **Danny A** (Noon Fellowship), **Dan M** (Higher Onondaga), and **Stephanie I** (Young at Heart); 15 eligible voters were present. **Will** presented the financial report. District/Area Liaison **Ben B** reported on the March GSR Workshop meeting, and asked that Intergroup Representatives get the word out that all are welcomed at the GSR Workshop; **Matt H** (Corrections) and **Stacey H** via email (Picnic) reported on their committees. There were no reports for Treatment, PI/CPC, Literature, Grapevine or Web/Archives. **Sally** reported on the March Steering Committee. February Intergroup minutes were unanimously approved. Under Old Business, **Sally** reported on her conversation with our GSO Liaison, **Craig W**, regarding **Chris P's** suggestion that we contact GSO and ask them to work with Google to remove the AA affiliation still displayed on Syracuse Group's website. After discussion, a vote was taken to table the issue so **Ben B** can discuss it with our Area 47 Rep, **Todd D**; motion carried. There was no New Business. The meeting closed with the Declaration of Unity at 6:45 PM.

Thaddeus also reported to the Steering Committee that all Intergroup committee chair positions have now been filled.

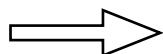
