For me, it was Ray. Although it was February and very cold, Ray stood outside the AA meeting and welcomed everyone with a big smile and a handshake. I was none too thrilled. But Ray sensed that. He reassured me I was in a good place. He then told me about his first meeting and that made me feel at ease. He talked to me almost as though I was his sibling. He made me feel like family.

Here was a guy I spent maybe 15 minutes of my life with, 11 years ago. I had never met a total stranger so concerned about my well-being, who wasn't trying to get something from me.

Later while reading "The Doctor's Opinion," I came across the word altruistic. It means showing unselfish interest or concern for the welfare of others. Before I got to AA, that concept had never entered my mind. That word described Ray.

I often get to be a greeter at my home group, and I accept that responsibility with all the passion and fervor I have. *Anonymous, Crown Point, Ind.*

You helped me

Thank you for the story "Prickly Worker" (December 2022) from the anonymous member in Sacramento. His final paragraph could have been written by me: "My suicidal depression never left me. I've never been joyous, only occasionally happy, but amazingly, I have always been free of the need to drink."

Since taking my most recent white chip 16 years ago—for what I hope is the last time—depression has continued to plague me despite prescriptions, psychiatrists, the Twelve Steps, much AA service and prayer.

During my first few years of sobriety, I never mentioned it at meetings or to my sponsor for fear of being accused of self-pity. Now I don't mention it because I don't want to discourage newcomers. It's a comfort to know that there's at least one other soul in AA who is also suffering and wants to remain anonymous.

Oh, I have something else in common with the writer. I too was 34 years old when I first got sober, but unlike him, I'm 81 now. Thank you, Anonymous in Sacramento. *Mary R., Indian Harbour Beach, Fla.*

Living in reality

For me recovery is about being restored to sanity or getting there for the first time. It's also being able to adjust to reality.

Hope became a stepping stone to belief. Given all the evidence to be found in any AA meeting, it's been hard to dismiss the chances of being able to find a lasting and happy life without needing to drink.

My early meetings would often end with the chairperson saying, "You can leave this room and never need to drink again." Back then, I was just trying to get enough sobriety to hold onto a job! Last Month's minutes: The committee reviewed the March 2023 minutes. **Sally** made a motion to approve the minutes, **Tim** seconded, and the motion was passed unanimously.

Tom K presented the March financial report:

Current Month: Checking and savings accounts are reconciled – total cash as of 3.31.23 is \$68,167.12. Net of \$1,542.01 of sales tax leaves \$66,625.11 of available cash at 3.31.23. Monthly revenues were \$8,966.30 and monthly expenses were \$8,715.67, resulting in net income of \$250.63. Contributions were \$6,012.43 and literature sales were \$1,856.41.

Year to Date: As of March 31, 2023 with the year 25.00% complete, total revenues are \$22,632.24, which is 28.53% of the budgeted amount. Total contributions are at 26.67% of the budgeted amount, group contributions are at 29.76% of the budgeted amount and individual contributions are at 30.77% of the budgeted amount. Literature sales are at 28.53% of the budgeted amount. All revenue items are trending above budget amounts. The year-to-date expenses are \$21,827.67, which is 27.52% of the budgeted amount, also trending above the budget amount, due primarily to a third payroll in March. The year-to-date net is \$1,234.74 vs the year-to-date loss of (\$3,398.52) as of 3.31.22 – a rather significant difference.

Service Center: There were 120 total calls in March, up 7% from February and 94 total office visits, down 10% from the previous month. Service Center staff responded to 124 email inquiries, up 13% from February. Between office visits, phone calls and email responses, Service Center staff have managed a total of 971 contacts in the first quarter of this year. (See graph below.)

Sally also reported that our website had once again been used as a credit card testing site, but such are the security precautions that have been put in place that out of thousands of attempts, only one transaction was successful. **Sally** worked with Stripe to immediately refund the card that was fraudulently charged. Also, on April 4, 2023, AAWS's price increase took effect. **Sally** calculated new prices for all the products we offer for sale and updated our accounting system to reflect the new charges for all of them, while **Josh** updated our website (online) ordering system with the new prices.



There is now a few extra steps to create and they can no longer be dynamically created.
